

Yuan Ze University Principles for Full-Time Faculty Applications for the "Yu-Ziang Yuan Ze Lecture" Selection and Recommendation Process

Article 1 The Hsu Yu-Ziang Memorial Foundation has established the "Yu-Ziang Yuan Ze Lecture" to encourage researchers at Yuan Ze University. In accordance with the foundation's "Guidelines on Yu-Ziang Yuan Ze Lecture Grant Application," the principles for selection and recommendation have been formulated.

Article 2 Eligibility Criteria:

1. The recipient must hold a full-time faculty position within the official staffing complement of Yuan Ze University throughout both the award and retention periods.
2. Applicants shall meet the qualifications outlined in the " Guidelines on Yu-Ziang Yuan Ze Lecture Grant Application."
3. Applicants who have not received the University's "Academic Lecture" grant are eligible.
4. Applicants shall meet the age requirements specified in the " Yu-Ziang Yuan Ze Lecture" tenure regulations and shall not retire before the term ends.

Article 3 Selection Process:

A "Yu-Ziang Yuan Ze Lecture" Review Committee is established, consisting of 7 to 11 persons. Each college shall recommend 1-2 distinguished external and internal scholars and experts in related fields. These recommendations will be consolidated by the Office of Research and Development and submitted to the President for approval, who will also appoint the committee chair. The term of office is one year. For the Committee meeting to proceed, the attendance of at least two-thirds of the members is required. All application materials will be jointly reviewed, and candidates shall receive approval from at least two-thirds of the attending members via a vote. The final recommendations will be submitted to the President for approval as the university's nominee list.

Article 4 Award Obligations and Restrictions:

1. Award recipients shall comply with the relevant regulations outlined in the "Guidelines on Yu-Ziang Yuan Ze Lecture Grant Application."
2. Recipients will receive a certificate, a trophy (or plaque), and a monetary award from the Hsu Yu-Ziang Memorial Foundation.
3. Awardees are required to remain in service for at least two years after receiving the award (counting from the date specified on the certificate issued by the foundation). If the recipient retires, resigns, or transfers to another institution before the expiration of the term of appointment or during the term, they shall return the full monetary award within one month of submitting their resignation or retirement request.
4. For individuals who resign or take unpaid leave during the term, the University reserves the right to withhold any unpaid awards.

Article 5 These regulations, as well as all subsequent revisions therewith, shall be duly adopted by the Administrative Council prior to implementation.
