## Operating Principles for the Selection and Recommendation of Full-Time Yuan Ze University Professors Applying for the "Y. Z. Hsu Outstanding Professor Award"

Article 1. The Far Eastern Y. Z. Hsu Science and Technology Memorial Foundation established the "Y.Z. Hsu Outstanding Professor Award" to encourage the popularization of science and technology, humanities, and medical technology. These operating principles for selection and recommendation have been established for this school based on the grant application measures for the "Y. Z. Hsu Outstanding Professor Award".

## Article 2. Application criteria

- 1. Applicants should conform to the conditions in the grant application measures for the "Y. Z. Hsu Outstanding Professor Award."
- 2. Applicants should have previously received awards for research excellence in their academic years as instructors of this school.
- 3. Applicants that have previously received the "Academic Chair" and "Y. Z. Hsu Yuan-Ze Chair Professor" awards of this school.

## Article 3. Selection method

A "Y. Z. Hsu Outstanding Professor Award" review committee is established. This committee comprises seven to nine people, with the head of R&D department acting as the convener. The head of R&D department recommends outstanding scholars from related fields within and without the school to act as committee members, and petitions the president for approval. These members serve for one year. At least two thirds of all members must be present for the committee to collectively review application data. Two thirds of the members present must vote to pass an application and petition the president to select a suitable quota to act as the recommended list of this school.

## Article 4. Obligations and restrictions for award winners

- 1. Applicants must conform to the stipulations in the grant application measures of the "Y. Z. Hsu Outstanding Professor Award".
- 2. Each person may only be presented this award twice.

- 3. During the award period, one may not present applications for Instructor Performance Research Excellence Awards and may not again apply to receive the Instructor Research Performance Award of this school.
- 4. Those who obtain this award should remain in the service of this school for two years following the fulfillment of the award period. If the award recipient leaves office during this five year period and transfers to another school, the entire award should be returned within a month following the application to leave office.
- 5. For those who leave office or remain in office without pay, the school may cease payment of the award yet to be issued.

Article 5. These measures have been announced and implemented after being passed by the Administrative Council. The same procedure is followed upon revision.

Note: If any controversies or disputes occurred regarding clauses of the aforesaid regulations, it shall always refer to its Chinese version.
