本申請單收費標準乃依據 112/01/17 修訂元智大學公務車申請使用辦法

The fee standard for this application form is based on the revised application and use regulations of YZU Regulations for Using the Official Car on January 17, 2023.

第五條 公務車收費標準:Article 5 Charges for official vehicles:

- 一、車輛使用:油料費:44 人座及 21 人座巴士每公里收費 25 元,出車基本里程為 50 公里,不足 50 公里以 50 公里收費,超過 50 公里則以車上里程表實際里程數為計算基準,計算後金額尾數不足 50 元者捨去,超過 50 元者以 50 元計。
  - 1. Vehicle Use: Fuel Fees: 44-seater and 21-seater buses are charged NT\$25 per kilometer. The minimum billing mileage is 50 kilometers. Trips under 50 kilometers will be billed as 50 kilometers. For trips over 50 kilometers, the actual odometer reading will be used. After calculation, if the remaining amount is less than NT\$50, it will be disregarded; if it exceeds NT\$50, it will be rounded up to NT\$50.
    - 9 人座公務車每公里收費 15 元,計費方式同上。

9-seater official vehicles are charged NT\$15 per kilometer, following the same calculation method as above.

上述費用於收費時提供加註元智大學統一編號之加油發票為繳費收據。

Official receipts with Yuan Ze University's tax ID from fuel purchases shall be provided as proof of payment.

- 二、駕駛人員延長工時加班費:
  - 依勞動基準法延長工作時間之工資標準加給,並由申請派車單位核銷。
  - 2. Overtime pay for drivers working extended hours:
    - Overtime compensation is calculated based on the extended working hours wage standards stipulated by the Labor Standards Act and shall be reimbursed by the requesting unit..
- 三、乘客(含駕駛員)平安保險,由申請派車單位依保險相關規定辦理。
  - 3. Passenger safety insurance, including coverage for the driver, shall be arranged by the requesting unit in accordance with relevant insurance regulations.
