- 一、本聘約之生效期間自__年__月__日起，至__年__月__日止，一年一聘，聘期至多三學年，三學年期滿如有特殊情形者，依本校「專案教師聘任辦法」辦理。

This contract is signed on an annual basis, and is valid for three academic years at most, effective from ____ (year) ____ (month) ____ (date) to ____ (year) ____ (month) ____ (date). In the event of special circumstances upon the completion of three Academic Years, procedures will be handled based on “YZU Regulations for Appointing Project-based Faculty”.

- 二、新聘一般專案教師應聘後，請按本校規定，辦理報到手續。一般專案教師每週應排定在校上班四天，負有教學、研究、輔導之義務與責任，並應配合學校暨院(同級)、系所(同級)需要，協助參與各項行政及服務工作。

New project-based faculty members shall follow the University’s regulations and complete the registration procedures after being hired. Project-based faculty members shall remain at school on duty for at least four days on a weekly basis and shall be responsible for teaching, research, and academic advice. They shall also collaborate with the school/college (or the same level) as well as the department (or the same level) to assist and participate in various administrative and service tasks as needed.

- 三、一般專案教師待遇依本校「專案教師聘任辦法」、「教職員工敘薪辦法」、「教職員工薪資核支要點」、「教師授課時數及抵免辦法」及「鐘點費支給標準表」等相關規定辦理，按月支給。一般專案教師之薪給，自實際到職之日起支。

The salaries for project-based faculty members shall be paid monthly in accordance with the following regulations of the University: “YZU Regulations for Appointing Project-based Faculty”, “YZU Regulations of Salary Assessment for Faculty And Staff”, “YZU Guidelines for Salary Payments to Faculty And Staff”, “YZU Required Faculty Teaching Load and Teaching Hour Waiver”, “YZU Hourly Wage Disbursement Standards Table”. Salaries shall be paid beginning from the date on which a teacher actually reports for duty.

- 四、一般專案教師利用本校相關資源進行研究發展所獲得之成果，除法令或契約另有訂定外，其依法取得之智慧財產權歸屬於本校。

Intellectual property rights of inventions derived from research and completed by a project-based faculty member using resources of the University all belong to the University, except for other regulations or contracts that provide otherwise.

- 五、一般專案教師應親自履行聘約，在聘任期間因故辭職者，須在一個月以前提出辭職書及辦理離職程序，聘約屆滿者亦應辦理離職程序，經校長同意後，於學期終了時，始可卸除職務。未依前述規定辦理離職者，應給付相當於一個月薪津（含本俸、學術研究費、津貼）之罰款。

Project-based faculty members shall fulfill the agreements of the contract. If faculties wish to terminate their employment prematurely during the contract period due to particular reasons, they shall submit a resignation letter which shall be approved by President and shall complete the departure procedures at least one month in advance. Those whose contracts are expiring

shall also complete the departure procedures. Faculties cannot leave their positions until the end of the semester. Failure to handle resignations in accordance with the aforementioned regulations shall result in a penalty equivalent to one month's salary (including base salary, academic research fees, and allowances) being paid.

- 六、一般專案教師應配合本校教育政策，接受相關評鑑，並依本校「教師評鑑與獎勵辦法」及相關法令規定辦理。

Project-based faculty members shall cooperate with the University's education policies and undergo relevant teacher evaluations which shall be processed in accordance with "YZU Faculty Evaluation and Rewards Regulations" and other related laws.

- 七、一般專案教師應配合學校行政作業要求，據實填報有關個人教學、研究、服務與輔導等事項之成果。

Project-based faculty members shall cooperate with the University's administrative requirements, and truthfully report their teaching, research, service, and counseling results.

- 八、專案教師均不得同時在校外其他公私立機關學校擔任專兼任職務；惟依本校教師校外兼課及兼職辦法規定申請核可者，不在此限，否則得予以解聘。

Project-based faculty members must not concurrently hold any full-time positions or job titles in any other public/private institutions/schools/companies, or they shall be dismissed from the University. However, those who apply for approval based on "YZU Regulations for Faculty Lecturing or Holding Concurrent Positions at Other Institutions" are not subject to this restriction.

- 九、專案教師接獲聘書後，應於二週內交回應聘書，逾期以不應聘論；如不應聘，請將本聘書連同應聘書一併退還本校人事室註銷。

Upon receipt of a new contract, project-based faculty members shall send back the agreement letter of employment within 2 weeks; those who fail to do so within this deadline will be regarded as not accepting the contract. If faculty members decide not to accept the contract, the contract and agreement letter shall be returned to Personnel Office in order to be nullified.

- 十、本校基於業務需要，得對其個人資料作電腦處理及使用，本校當善盡資料保護之責任。

The University may process or use faculty members' personal data on the computer when necessary, and shall protect the data to prevent harm on personality rights.

- 十一、專案教師應恪遵教師專業倫理規範，維護師道尊嚴，謹言慎行，並負有維護校譽之責。教師如有違反政府法令、本校規範或聘約規定之行為，應依相關規定辦理；其情節未達「教師法」規定之解聘、不續聘或停聘者，得提請各級教師評審委員會審議，並視違規情節輕重，處以或併處一定期間之停權措施。教師如認為其個人權益受損害，應先循本校之申訴程序，依法提出申訴。

Project-based faculty members shall strictly observe the professional ethical standards of the teaching profession, uphold the dignity and integrity of the faculty role, exercise due restraint and prudence in speech and conduct, and shall be obligated to safeguard and promote the reputation of the University. Any act by a faculty member in violation of applicable laws or regulations, the University's rules or policies, or the provisions of this Appointment Contract shall be subject to disposition in accordance with relevant regulations. Where such violation does not constitute grounds for dismissal, non-renewal of appointment, or suspension as prescribed under the Teachers' Act, the case may be referred to faculty evaluation committees at the appropriate levels for deliberation. Depending on the nature and severity of the violation, disciplinary measures, including the suspension of specific rights for a prescribed period, may be imposed, either individually or cumulatively. Where a faculty member alleges that his or

her lawful rights or interests have been infringed, such faculty member shall first exhaust the grievance and appeal procedures established by the University and shall file an appeal in accordance with applicable.

十二、專案教師在職期間須遵守「性別平等教育法」、「校園性別事件防治準則」、「性別平等工作法」及「性騷擾防治法」等相關規定。

Project-based faculty members shall comply with the “Gender Equity Education Act”, “Regulations Governing Prevention of Gender-Related Incidents on Campuses”, “Gender Equality in Employment Act”, “Sexual Harassment Prevention Act”, and other related laws.

十三、專案教師請假依本校「教職員請假休假辦法」辦理。

Project-based faculty members asking for leave of absence shall process in accordance with “YZU Regulations for Faculty And Staff’s Leave of Absence”.

十四、本聘約未盡事宜，均依照教育法令暨本校相關規定辦理。

Matters concerning the rights and duties between faculty member and YZU not specified in the contract shall be dealt with according to the relevant education rules of MOE and YZU regulations.

十五、本聘約經校務會議通過後實施，修正時亦同。

These regulations are adopted by University Affairs Meeting, as shall amendments when they are made.

In case of any discrepancy between Chinese and English version, the Chinese version shall prevail.
