成大副校長張俊彦:

"我想再強調一遍,成大絕對沒有結構性的因素,會去鼓勵老師投遞掠奪性期刊,因為他做這些事是徒勞無功、 沒有 credit 的。如果一個學者的履歷,列出來的論文都是 這種雜誌,我們的面試官第一個就把他丟到垃圾桶。"

• 整體結構性因素,這句話當然正確!

學術界偏重以「點數」 (Impact Factor) 來評量學術單位、教師研究能量。學術從業人員為求教職、升等、評鑑則必須提供「考績」,職位才能穩坐。

但是,學術經費、升等年限等多方壓力,研究考績偏弱的研究人員, 眼看年限將至,寧願**盲人騎瞎馬**。

也就是說,有人願打,有人願挨,有人選擇「不去查證」? (需要你的刊登費) (反正會幫我快速出版‧多一篇是一篇) (就真的有刊登阿...)

屆時出包,再來爭執自己有多無辜...... (我真的甚麼都不知道阿... 嗚嗚 QQ)

- 「掠奪性期刊」(Predatory Journal)、
 「掠奪性研討會」(Predatory Conference)
- 目的是甚麼?
 - 營利!! 毫無學術交流可言!!
- 背後的利益是甚麼?
 - 你繳的刊登費
- 交換的利益是?
 - 出版商要營利,研究人員要發表績效,雙方各取所需??
 - 或,真的是迷途的小白兔,誤闖森林禁地??



事件的起源是這樣發生的...

傳統出版商的穩贏模式

- 1. 商業學術出版商漁翁得利
 - 投稿人:提供出刊的內容,
 - 學術研究機構:繳納訂閱費,取得使用權 (access right)
- 2. 購買這些學術期刊的費用越來越高,多數學校根本無法負擔
 - 成功大學,2017年全校書刊經費1億7313萬元, (期刊資料(含電子期刊)、電子資料庫(電子書)共1億5446萬元,佔總支出89%)
 - 哈佛大學,2012年,圖書館期刊訂閱費用350萬美金
- 3. 圖書館沒有實際擁有一份圖書館館藏,僅能在合約期限內使用,合約到期、 軟硬體限制等因素則失去使用權 (部分雖有永久使用權,但訂購費高)
- 4. 商業學術出版社要求作者以排他授權方式,將著作權讓給出版社
 - 作者本身 (研究人員) 失去自己公開、傳播自身著作的權力





開放取用/近用 (Open Access)

- 扭轉獨厚出版商的窘境,擴大研究資源的公開主要訴求
- 提出 3 個國際宣言《布達佩斯/貝塞斯達/柏林公開取用宣言》
 - 確立 Open Access 發展方向
 - 2種主要途徑
 - <u>自我典藏 (self archiving)</u>
 - 鼓勵學者將學術成果電子檔公開於機構典藏供大眾全文閱讀
 - 開放近用期刊 (Open Access Journal)
 - 學術文獻透過公共網路、免費使用,不因經濟、法律與技術等 障礙限制
 - 允許自由閱讀、下載、複製、傳播、列印、檢索等從事其他任何合法使用



Open Access 期刊營運模式 I

- 與傳統期刊相同,皆須透過同儕審查!!
- 沒有訂閱費。那,出版商怎麼營運?
 - 費用轉嫁於投稿人 (作者),支付論文處理費 (Article Processing Charges, APCs) 或刊登費,以維持營運
 - 外文 Open Access 期刊收費,介於 1000-3000 美元
 - 部分電子期刊出版商 (SAGE、Elsevier、Springer、 Taylor & Francis) 提供複合式 Open Access (Hybrid Open Access)
 - 2500-3000 美金



掠奪性期刊的詐騙行為



- 披著「Open Access 經營模式」的皮,卻只為「營利」之實
 - 1) 宣稱為 Open Access 期刊, 賺取由作者支付論文處理費
 - 2) 宣稱有同儕審查 (正常審稿期間需要 3-6 個月),實際卻是以最短時間內刊登,文章也無須大幅修改 (甚至連改都沒改!)
- 簽署著作權讓渡書,傳統期刊會於稿件接受刊登才會要求簽屬;掠奪性期刊可能在2個時機點要求:
 - 1) 投稿時,一併與稿件提交
 - 2) 接受刊登時要求
- 對於作者的影響
 - 1) <u>白費學術成果</u>:當發現誤擲到掠奪性期刊想撤稿,掠奪性出版商會不理你;如果已簽屬讓渡書時,想撤稿的機會更加渺茫
 - 2) <u>玷汙學者清譽</u>:一旦與掠奪性期刊沾上邊,「取巧」、「短時間想 累積成果」「求量不求質」的惡名很難洗清

- 1. 主動寄信到學校/公務信箱,標題打出 JIF、主動來邀稿,可能是掠奪性期刊
 - 強調影響係數
 - 強調審查天數 (可能 2 周、29 天),但都比傳統審查期快速!!
 - 方便操作,提供超連結
- 2. 查看期刊所屬的網頁、瀏覽幾項要素
 - 是否有同名不同身 (相同刊名、縮寫相同、網址相同)
 - 影響係數 (來自 JCR,還是其他? 如 GOOGLE Scholar)
 - 查閱期刊解說,是否刊名前後不一致、出版流程不明
- 3. 出版商/期刊,著作權讓渡程度
 - 作者是否保由著作權
 - 能否申請放入學術/研究機構典藏

As an excellent writer/author in your field, you deserve to be published without being rejected;

- 1. Make sure your research title describes (a) the topic, (b) the method, (c) the sample, and (d) the results of your study
- 2. The abstract should be self-contained, citation-free, and should not exceed 200 words. An abstract is a brief summary of a research article, thesis, review, conference proceeding, or any in-depth analysis of a particular subject and is often used to help the reader quickly ascertain the paper's purpose.
- Format your paper according to standard of the journal.
- 4. Remove the plagiarism.

Average Review Time: 29 days

- 5. Length of the article should be appropriate.
- 6. Review spelling and grammaatical errors.
- 7. Add conflicts of interest, author biography and cover letter.
- 8. Add appropriate number of references in proper format.
- 9. Submission (Help Video)

Peer Review process: Journal uses double blind peer review system to ensure originality, timeliness, relevance and readability

Impact Factor

The **impact factor** (IF) is a measure of the frequency with which the average article in a journal has been cited in a particular year. The **impact factor** is used to measure the importance or rank of a journal by calculating the times it's articles are cited.

The ICI Journals Master List database contains over 22 000 journals, including 3000 from Poland. Journals that are registered here, underwent a multidimensional parameterization successfully. As a confirmation of the indexation in our database journals receive the ICV (Index Copernicus Value).



5 Year Journal Impact Factor

The 5 year journal impact factor is the average number of times, the articles published in a journal get cited in last 5 years. It is calculated by dividing the number of citations received with the total number of articles published in previous five years. The 5 year journal impact factor is available only for the journals that completed 5 or more volumes.

Aggregate Journal Impact Factor

The aggregate journal impact factor for a subject category is calculated using the same method as the journal impact factor for a journal, but it also includes the number of citations for all journals in the category and the number of articles from all journals in the category. An aggregate journal impact factor of 1.0 implies that the articles in the subject category published in recent two years have been cited once on an average. The median Impact factor is the median value of all journals impact factors in the subject category. The journal impact factor extenuates the significance of absolute citation frequencies. It alleviates the advantage of large journals over small journals because large journals circulate a larger body of citable literature. It also mitigates the benefit of frequently issued journals over less frequently issued ones and of older journals over newer ones. For the reason that the journal impact factor offsets the advantages of size and age and it is a helpful contrivance for journal evaluation.

*2017 Journal Impact Factor was established by dividing the number of articles published in 2015 and 2016 with the number of times they are cited in 2017 based on Google Scholar Citation Index database. If 'X' is the total number of articles published in 2015 and 2016, and 'Y' is the number of times these articles were cited in indexed journals during 2017 then, journal impact factor = Y/X

以成大來說,除了 WOS (SCI/SSCI/A&HCI) 資料庫,生醫領域仍可透過 PubMed (美國國家醫學圖書館所建置)、工程領域以Compendex (包含常見 IEEE 標準等) 資料庫,擴大搜尋資源。

以關鍵字搜尋資料庫,了解各領域研究進程,確立研究方向。 更重要的是能夠<u>免於劣質文獻干擾、甚至是掠奪性期刊所刊登</u> 的文章,不僅浪費研究經費與資源,更毀壞自己的清譽。

成大花了 1.5 億費用購買上述的資料庫,仍因掠奪性期刊蒙羞, 實屬冤枉;希望能藉此讓更多研究人員改變搜尋文獻的習慣。
