## Yuan Ze University Guidelines for Dormitory Network Management

Approved at the 1<sup>st</sup> Information Services Meeting , Academic Year2020, on May 4, 2020 Revised and approved at the 1<sup>st</sup> Information Services Meeting, Academic Year 2023, on Dec. 13, 2023

Article 1 Application Qualifications and Usage Instructions

- 1.1 The applicant must be a dormitory resident at Yuan Ze University. The residence qualification shall be determined based on the announcements made by the Dormitory Service Division of the Student Affairs Office.
- 1.2 The applicant has to bring his/her own personal computer, RJ45 network card and Ethernet cable. The applicant can access the Internet by simply connecting the cable to the LAN port.
- Article 2 For usage regulations, please refer to the 「Yuan Ze University Network Usage Management Regulations」.
- Article 3 Fault Reporting
  - 3.1 Several student volunteers, appointed by the university, are responsible for repairs in areas under the responsibility of the university.
  - 3.2 More specifically, network connections from the server room up to the LAN port on the wall of the dormitory room are under the responsibility of the university.
  - 3.3 In case of network abnormality or no access to the Internet, or if the LAN port in the dormitory room is damaged, please perform a self-check first. If the issue persists, please report it through the customer service system via the personal port or fill out a paper form at the front desk of the dormitory.
- Article 4 Violations and Sanctions
  - 4.1 Any violation of the Taiwan Academic Network Management and Norms and the Campus Network Usage Regulations issued by the Ministry of Education will be reported to the university for disciplinary action.
  - 4.2 Illegal software shall not be used in the dormitory. The user shall bear full responsibility if being reported.
  - 4.3 In the event of inappropriate Internet usage, regardless of whether it affects the rights of the user or others, the university has the right to terminate the network connection, and the user has no right to object to the decision.
  - 4.4 In case of reported illegal online activities, the university reserves the right to disclose personal data of the user to the authorities for investigation purposes.
  - 4.5 If the LAN port in the dormitory room is damaged due to user negligence, the user shall be responsible for arranging repairs or reimbursing costs of repairs or replacement.
  - 4.6 In the event of any of the following circumstances, upon discovery, the university has the right to terminate the Internet access of the user:

- 4.6.1.Construction of any type of servers, including but not limited to WWW, FTP, DNS, and mining servers, will result in a one-month suspension of the Internet access.
- 4.6.2.If all other users are adversely affected by the high network traffic due to online gaming in the dormitory, the network speed to the user shall be slowed down.
- 4.7 If the user possesses multiple computers, the sanctions for violations shall be determined based on the individual user, instead of each single computer.
- Article 5 These guidelines will be officially announced and enforced after approval by the Information Services Meeting. The same applies to further revisions.
